5. A **refundable Move-in/move-out deposit of \$500** is required at the time of application. The deposit will be placed in an escrow account and used only in the event of damage to the common elements during the move. The deposit will be returned after the move-out
6. If the applicant is on foreign visa prices are accordingly. Copy of Visa and Passport required.
7. A Copy of a Photo ID (Driver's license or Passport) is required with all applications before a background check is initiated.
8. A copy of all Vehicle registrations and Car insurance. Is also required to be attached to the application.
9. The complete application must be submitted to the management office at least **Twenty days** prior to the closing date or lease date whichever applies. (**Rush fee for applications is available \$200**)
